## ConDem's Coalition Policies on Gypsies and Travellers

**Since the General Election in May brought the ConDem coalition to power the political landscape has already radically shifted for Gypsies and Travellers. Chris Whitwell, Director of FFT, looks at post-election changes to Government policy and initiatives, and the effect of potential future legislation.**

Now that the dust has settled after the General Election we are beginning to see something of the direction in which the new Coalition Government is taking us – and some of the signs are extremely worrying for those concerned with bringing about an equal, fair and just society. For Gypsies and Travellers one of the most immediate concerns has been the scrapping of the £30 million grant earmarked for local authorities to enable them to bring forward new sites and refurbish existing ones. This, coupled with moves to criminalise trespass and to curb the submission of retrospective planning applications could have a profound impact on the 25,000 or members of the travelling communities who still have no authorised site on which to place their home but who face a continual process of eviction after eviction.

There are other dark clouds on the horizon and, just perhaps, one small ray of sunshine to give some hope for the future.

First, the clouds though. The whole 'localism' agenda being pedalled by the Coalition may well serve to prevent the implementation of developments that, although unpopular locally, may be strategically necessary in the wider interests of society. In the past regional planning bodies have provided something of a strategic overview to ensure that each local area is meeting its responsibilities in terms of land allocations. This will no longer be the case and it is difficult to see how in future the system will deliver those unpopular but necessary land use decisions.

These fundamental issues of the need for a strategic overview are also being played out in the fields of healthcare and education.. The ideology of the 'Big Society' may well have benefits for the better off majority but it could well leave those who have no effective voice - the poor, the marginalised and the 'chronically excluded' – even further behind, with

fewer choices and poorer life outcomes.

And the small ray of sunshine? The move away from local authority Gypsy site provision might just spark off an interest in other, and better, ways of developing and providing sites to meet the current shortfall. There is growing interest in the idea of Community Land Trusts where land is held by the Gypsy/Traveller group themselves on a cooperative basis. There is also the intriguing possibility of self build options with part of the development costs of land being met by the 'sweat equity' of the Travellers themselves. Such options could deliver smaller, privately owned sites, more suited to the needs of Gypsies and Travellers than large Council run sites.

And in these difficult times, let's face it, we have to hang onto something to be optimistic about!

## News from the Health Team

I thought since we now have a change of Government and are faced with the prospect of ongoing and harsh budget cuts, that it is important to think about how this might impact on the health inequalities faced by many Gypsies and Travellers.

Something that is much talked about at FFT is the concept of 'Chronic Exclusion', by this we mean that there are certain groups of people who for a whole multitude of reasons do not enjoy the same rights and choices as the majority of us.

The Labour Government did much to improve the health of the nation, which is something that we have all benefited from on the whole. However, what it has failed to do is to redress the growing divide between the 'haves' and the 'have nots'. In other words the gap is getting bigger.

This theme was reaffirmed by the recent findings of the newly released National Audit Office report on health inequalities (Tackling Inequalities in Life Expectancy in Areas with the Worst Health and Deprivation, 2 July 2010). It

has come as no surprise to third sector organisations working in the inequalities field. It is not only in health outcomes that the equalities gap continues to widen but in various other areas, all of which contribute of course to our health and wellbeing.

We believe that the attempts of successive Governments to implement initiatives aimed at achieving greater equality, widening choice and participation, and empowering communities have tended to work reasonably well for the majority but have left certain groups totally untouched. It is essential that when we talk about better community engagement, that we recognise that this should be inclusive of all communities, not just those who are in the fortunate position of being organised enough, wealthy enough and well enough to engage with NHS mechanisms. As a result these people – the 'Chronically Excluded' - can become even more marginalised and excluded, even more disempowered with less

personal choice and poorer life outcomes.

However, many of these chronically excluded people are already linked into specialist services who outreach and support their often multiple and complex needs. If the Government is serious about a fully inclusive health service, we need to support these people to have a voice and become involved.

The Health Team continue to outreach and support many Gypsies and Travellers across Sussex, an essential part of our work! However, we also need to ensure that we do not let the good work that has been achieved by FFT, other Traveller organisations and by the many Gypsy and Traveller activists, lose momentum. We are always keen to hear from any Gypsies and Travellers who would like to become involved in their Local Involvement Networks (LINKS). Please contact FFT if you are interested.

## News from the Young People's Project

An Awards for All grant of £9,936 is enabling us to have a fun and full packed holiday activity programme until April 2011. The funding is covering a series of 6 weekly dress making courses starting in mid October for 12 young people, motor safety and maintenance for 24 young people with off road

obstacle courses in partnership with young drive, an animal project looking at the different ways young people can work with animals, swimming lessons, and accredited courses in kayaking, canoeing, archery and team building exercises including raft building, high wire and

obstacle courses. We have also recently received some funding from Mid Sussex Well Being grant to run a pilot football team with the Brighton & Hove Albion's. This is intended to start at the beginning of September until the October half term on a weekly basis.

## Case Work Update

**Abbie Kirkby reports the on the case work she and Michelle Buck have been handling at FFT in recent months.**

As far as the national casework goes, we have opened 39 new cases since April. 16 of these cases are with Romany Gypsies, 19 have been with Irish Travellers and 4 with New Travellers.

A lot of these cases are in the South East (21), and

with 6 cases in the Midlands, 4 in the South West as well as cases in the East of England and the North East and North West. Some of the issues that we have been dealing with are problems with the Police, problems on sites or accessing them, planning issues, housing issues, accessing grants and education.

In addition to the recently opened cases we are also working on cases from

before April – some cases are quite complex and involve a lot of work over a long period. We are always happy to deal with any queries you have or to help you if you need any assistance with a particular problem you may be facing – please contact us on our national advice line 01273 234777.

## Health Community Development Worker's Update

**Jazka and Lisa report on their work in the community and give an update on the training they have delivered and what is in the pipeline**

Through our work in the Health Promotion Team at FFT over the past 2 years it has become clear that Gypsies and Travellers have real problems accessing healthcare. In particular people living by the roadside and with no proof of address or ID find it very hard to register with GP Surgeries, get second appointments or be referred to other health care services like Occupational Therapists and Community Support Workers. Many people we support have told us stories of being refused short-term GP registration, of not being given proper support to ask for referrals and not understanding information about medications and treatments. Travellers have also experienced

prejudice and discrimination from NHS staff and there seems to be a general misunderstanding of Gypsy Traveller culture amongst health workers.

We have carried out lots of awareness training with NHS healthcare teams over the past 2 years and are now focusing our effort on GP Surgeries. Over the next 3 months we will be putting together a research and recommendations report on GP healthcare in Sussex. The report will give good and bad examples of access to GP surgeries with anonymous case studies of people's experiences. The report will also make recommendations to Primary Care Trusts and GP Surgeries on how to ensure Gypsies and Travellers have equal access to healthcare and also include Best Practise examples of GP Surgeries and outreach services that work well across Sussex. If you have had a good or bad experience with your GP

Surgery including reception staff, nurses and information about your surgery or have been unable to register with your local GP Surgery then get in touch with Jazka Atterbury at FFT in Brighton.

We are also developing a series of resources for Travellers on Wellbeing and emotional health topics – such as bad nerves, baby blues, eating problems etc. We will be producing leaflets, a CD and also a book, all on Wellbeing. We are doing this in partnership with community members and Wellbeing practitioners.

We are also continuing our work in our 2 local prisons. With the FFT Reaching Communities team, we are co-organising, with Travellers from within the prison, an event for Gypsy and Traveller History month in HMP Ford. This is to raise awareness of Gypsy Traveller culture within the prison and also provide a day of celebration for

Traveller inmates. In HMP Lewes, we will be taking part in a research survey on the BME inmates within the prison and use this information to improve their Wellbeing services.

## A tribute to Michael Gavin - activist, father and friend

I would like to pay tribute to Michael Gavin, a local Irish Traveller Activist who recently died after a long and brave battle against cancer, aged just 48 yrs old. I was lucky enough to know Michael for ten years, having met him when our daughters met at Primary school. Michael was a good friend and mentor to me. He educated me about the history and present day situation of Irish Travellers and Romany Gypsies, and opened my eyes to a whole new world that I had previously been largely unaware of. I worked with Michael for over two years helping out with the grass roots group he had founded called 'Gypsies and Irish Travellers' and we used to travel to the Gypsy Traveller Advisory Group together where I had the unique opportunity to see him in action raising the Sussex Police's awareness about Gypsy and Traveller issues.

Geoff Foster Equality & Diversity Liaison Officer at Sussex Police said of Michael:  
 "He challenged us and educated us but at all times he did it in a constructive, supportive and professional manner."

I witnessed Michael having to be surprisingly insistent that equality is not something you have to earn, or that only some members of society can expect, and that Gypsies and Travellers should also be afforded equal rights because they too are members of the diverse communities we live in.

Michael's widow Michelle continues to support and work with all Gypsies and Travellers in her capacity as full-time Caseworker at Friends, Families and Travellers.

Michael, you were a dear friend, God Bless You and may you rest in peace.

Greg is also a Trustee of FFT.

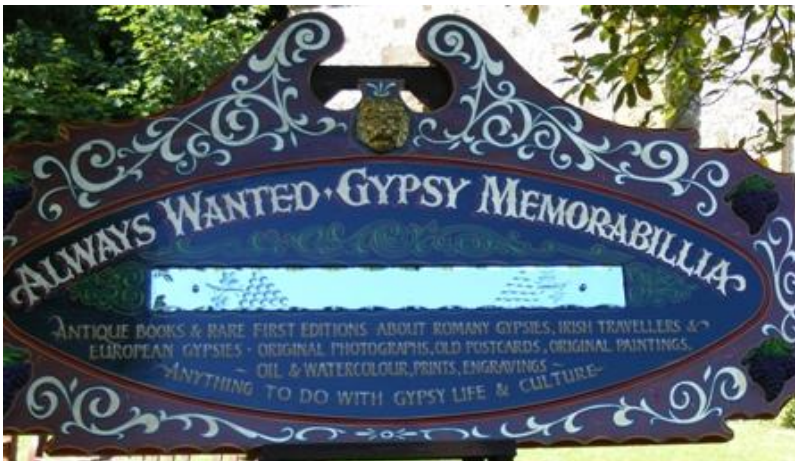

On 7<sup>th</sup> July 2010 the Inaugural meeting /AGM of the All Party Parliamentary Group- serviced by the Policy Officer for the Traveller Law Reform Project (Lucy Beckett), was held in the Palace of Westminster. The Agenda included the election of Officers and discussion of main issues.

committed to addressing the social inclusion of Gypsy Roma Traveller communities, improving community relations, and tackling accommodation issues. The APPG GRT is also committed to forging cross Party consensus so that all parliamentarians can work together to achieve the aims of the Group.

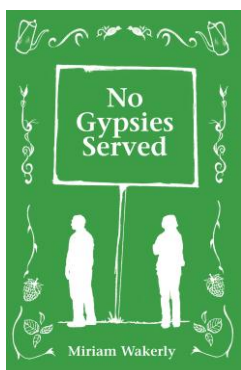

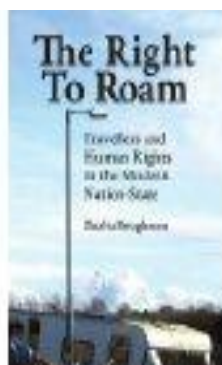

### Stand Up and Be Counted, Make Your Voice Heard!

The next census, taking  
place in March 2011, will  
be of great historical  
importance for Traveller  
communities in England  
and Wales. For the first  
time ever, the census  
questionnaire will allow  
people to tick their ethnic  
identity as a Gypsy or Irish  
Traveller.

The census collects  
information about the  
whole population every ten  
years to show what  
support and services  
different communities  
need. The results are  
used, for example, to help  
plan school places, health  
facilities, public transport  
and emergency services.  
It’s so important that  
Gypsies and Irish  
Travellers fill it in next  
March and tick the box to  
mark their identity so that  
the community and its  
needs will be recognised.

It’s a big chance for  
Gypsies and Irish  
Travellers to stand up and  
be counted.
