New Agency takes on site grants

Iain Wright MP, the Parliamentary Under-Secretary of State for Communities and Local Government, has announced that the new Homes and Communities Agency will take on the responsibility for administering Gypsy and Traveller site grants as from 1 December 2008. In his announcement he said that the Agency would, because of its close relationship with local authorities and other delivery partners, be 'well placed to step up the pace of delivery for the benefit of both Gypsies and Travellers and the settled community'.

We hope he is right. Since the £97 million grant was announced last December there has been precious little evidence of local Councils taking positive action to bring forward sites, although there have been many fine words about intentions to do so. We believe that the vast majority of local Councils are disinclined to rush ahead with site provision, preferring to wait and see what comes out of the regional site allocations.

Those local authorities that are taking their responsibilities seriously and trying to bring forward sites will need help in ensuring that their good intentions don't collapse once the Nimbys, racists and anti campaigners begin to mobilise to fight proposals for sites in their area. Central Government needs to understand that Gypsy and Traveller communities have to be fully involved in this crucial delivery stage of the process if progress is to be made, and that this work needs to be properly resourced.

We hope that this is a factor that the Homes and Communities Agency will recognise, and will be able to make sufficient funding available to ensure that the delivery of sites proceeds in full partnership with the travelling community. Without this vital injection of funding we foresee many local authorities simply putting site provision into the 'too difficult' box and biding their time in the hope that the issue will go away.

It won't. It is a national disgrace that in 2008 we still have around 20,000 to 25,000 travelling people who have no 'legal' site and we will continue to put pressure on central, regional and local Government to bring an end to this shameful state of affairs.

Young People's Summer Fun

This summer has seen a very full and varied holiday activities programme working with about 70 young people across the whole of Sussex, with the support of parents, older young Travellers who have provided peer support, Connexions in West Sussex and the Circle of Life Project based in East Sussex.

Two separate groups of young people applied for, and were awarded youth opportunity funds in West Sussex. This empowered them to apply for their funds, research costs, plan activities and decide where they wanted to go with a majority consensus being reached on several sites. This was the first time these young people had applied for funds and had the opportunity to decide what they wanted to do in their

summer holidays. New experiences were gained and fears overcome particularly by a group who decided to go ice skating for the first time ever.

FFT worked in partnership this summer with the circle of life project which involved several days activities in the woods activities in the woods including making traditional healing potions, cooking on an open fire, tree clay sculptures and an adult from the community showing a group of young men how to make primrose baskets.

Pavee Point Exchange

FFT took part in its first ever youth exchange this summer with 11 young Travellers from Dublin coming to visit us with

Pavee Point and spending a week end getting to know a group of young Travellers from FFT's young people's project. The three days involved the initial meeting in Brighton on Friday afternoon, a trip to Powdermill Woods doing activities including rock climbing, an assault sausages, bananas with chocolate and the odd marsh mellow or two on a fire, and then attending the Romany Gypsy Arts festival at Hop Farm and being interviewed by Jake Bowers about their experiences. A fairly hectic week end had by everyone and experiences of Traveller cultural ways were shared amongst the group from cooking, to music and langauge.

Sussex Women's Projects

The Health Project groups have evolved into a bite size education project coordinated by Gemma Challenger (Well-being Community Support Worker) and Rebekah Dilley (Health Community Support worker)

The new bite size courses are aimed to give free taster sessions to anyone in the Gypsy and Traveller

community. So far we have Homeopathy First Aid, Reflexology, Belly dancing, Street dancing, Head massage and Computer and Internet use. We are working on some other exciting leads to complete our 10 bite size courses.

As soon as these are finalised we will be putting together our course brochure stating all the course details, venues and pick up points. If anyone is interested in any of the courses they should contact FFT for more details. Should anyone be interested in delivering a Health or Well-being course of their own please contact Gemma or Rebekah to discuss this. The courses will start at the end of October and we will keep you posted on their success.

Advice and Policy Update

Advice Work

FFT offers advice, information and casework to all Gypsies and Travellers who seek our help. These cases are a small selection of the wide variety of cases from around the UK in 2007/8.

A. Site Management

This case relates to residents on a Gypsy site in the South East who were unhappy about the management of their site. FFT started regular meetings between site residents and the local authority which resulted in the local authority appointing a dedicated site manager and applying for a government Gypsy Sites Refurbishment Grant to improve the site.

B. Discrimination

One of our Irish Traveller clients in the South West reported an issue of discrimination. The council-run site she is living on was experiencing problems receiving orders from a delivery company. An employee of the company told the Irish Traveller that the company would not deliver to the address as it was a Traveller site. After FFT made some enquiries with the company they denied the allegation made against them but deliveries to the site soon commenced. The issue was reported to the **Equalities and Human** Rights Commission.

C. Eviction Threat

A group of New Travellers were parked on private land in the East of England. They had made an agreement with the landowner to stay for a short while so they could complete repairs to their vehicles. Unexpectedly the police arrived at the site with a section 61 notice. FFT worked alongside the local Gypsy Liaison Officer to revoke the section 61 notice. The private landowner had not given the Travellers notice to leave which must be done before a section 61 can be considered by the police. The agreement between the landowner and the Travellers was reinstated and they were able to stay on the land.

D. Tribunal Support

A young Gypsy living in the South East was having problems with her Incapacity Benefit. She had missed a couple of medical appointments due to being constantly evicted and the Benefits Office stopped her benefit. FFT launched an appeal to get the benefit reinstated and the tribunal came out in her favour and recognised that she was undergoing difficult times and the benefit was restored and backdated.

Policy Work

SEERA (the South East Regional Assembly) is currently consulting on proposed new Gypsy/Traveller pitch numbers and local authorities in which they will be, in the South East region. The consultation runs until 21 November 2008.

Key consultation questions include:

- Is 1,064 new pitches for Gypsies/Travellers in the south east a suitable 10 year target?
- Is 276 new pitches for Travelling Showpeople in the south east a suitable 10 year target?
- Which of four options gives the most suitable spread of pitches across the region?

News from the Traveller Law Reform Project

Jurisdiction in disputes on Mobile Homes Act sites

The department for Communities and Local Government is currently consulting on proposed changes to the way disputes are resolved on sites covered by the Mobile Homes Act 1983. Once the Housing and Regeneration Bill becomes law, local authority Gypsy and Traveller sites will come under the provisions of the Mobile Homes Act 1983, so the proposed changes to dispute resolution will affect residents of those sites as well.

The Government's preferred option, subject to the views of consultees, is to transfer jurisdiction for all matters that can currently go the county court to a Residential Property Tribunal - except cases where the site owner is seeking to terminate the agreement, which would still be dealt with by the county court. If, following consultation, the Government decides to proceed with this option, it also proposes that agreements under the Mobile Homes Act should not be allowed to bind site owners and residents to

resolving disputes through arbitration. You can read the Government's proposals at

At present, some pitch agreements on Mobile Homes Act sites force residents who are in dispute with the site owner to accept arbitration by someone appointed by the site owner. TLRP believes that this is unfair, and the Government agrees. But TLRP disagrees with the Government on how to address this injustice. TLRP believes that residents should always have the right to take a dispute to the county court, where they may be eligible for legal aid if they cannot afford legal representation themselves. The Government believes that all disputes other than those where the site owner seeks possession of the pitch should be resolved by Residential Property Tribunals, where the parties in dispute have no right to legal aid. TLRP believes that site residents will need legal representation in such disputes, and should have the right to legal aid if they cannot afford to pay - so they must have the right

to go to a court, not a tribunal. You can read TLRP's response to the CLG consultation at

CLG consultation on other aspects of the Mobile Homes Act

Communities and Local Government is also planning to consult on other aspects of the Mobile Homes Act that would affect local authority Gypsy and Traveller sites once the Housing and Regeneration Bill becomes law.

A lot of concern was expressed by Gypsies and Travellers earlier this year about the Mobile Homes Act's arrangements for pitch assignment and succession. Many Gypsies and Travellers said that these arrangements would not work on local authority Gypsy and Traveller sites. The Mobile Homes Act gives the Secretary of State for Communities and Local Government the power to exempt such sites from these arrangements, and the CLG consultation will seek people's views on whether or not this should be done. The consultation document should be published in August.

Education and Skills Bill

The Government in its Education and Skills Bill intends to raise the compulsory education leaving age to eighteen, and to see all adolescents engaged in academic education, training or vocational apprenticeships. This programme will be obligatory and noncompliance could lead to prosecution. Although TLRP welcomes the efforts being made through the Bill to improve the quality and flexibility of education and training for 16-18 year olds, there is great concern about the effect of introducing compulsion.

One matter of particular importance to many young Traveller women will be the Bill's interference with their right to choose to be full time mothers. Many Traveller women marry at age 16 or 17 and become mothers in the first year or two of marriage, and they have the legal right to choose to do so. It would, however, appear that, while an 18 year old mother has the right to be a full-time parent, a 16 or 17 year old mother does not, which raises issues of age discrimination. The insistence that any young mother in this situation should leave her young

children in the care of others while attending structured education or training sessions will seem perverse to many Travellers. The Government should acknowledge that work in the home, particularly work as a mother, is every bit as valuable as work outside the home. Raising the next generation of citizens and workers is an honourable and very demanding occupation and should be recognised as such.

Gypsy and Traveller Accommodation Assessments

Since ODPM Circular 1/2006 was issued. following the Housing Act (2004), Gypsy and Traveller Accommodation Assessments (GTAAs) have been carried out and published for much of England, and all areas will have published GTAAs by the end of 2008. These accommodation assessments will inform development of policy at regional and local level, leading to pitch allocations to meet the assessed need.

There has been considerable development of Regional Planning Policy, with a number of single issue Partial Reviews of Regional Spatial Strategies under way. All local authorities are embarking on new Local Development Frameworks and are proceeding with Core Strategies (which outline proposed strategies for development) and **Allocations Documents** (which identify land for development).

A very significant proportion of GTAAs have been found not to be adequate for their main purpose

 identifying the necessary numbers of pitches, both residential and transit, for Gypsies and Travellers.

Very many of them make estimates of need that are much too conservative, often because they are based on unreliable caravan count figures. (Local authorities are required to count all Gypsy and Traveller caravans in their areas in January and July each year. These figures are widely regarded as too low, as some council officers spend no more than two hours on the exercise, suggesting that they have not left their desks. Nonetheless, the caravan count produces a figure which can be accepted as an absolute minimum.)

Despite this fact, some local authorities are challenging either their own GTAAs or their pitch allocation from their Regional Assembly on the grounds that the allocation is too high. Where local authorities have already suggested possible new sites for Gypsies and Travellers, opposition from local settled residents has sometimes reached hysterical proportions.

The guide does not cover the particular needs of New Travellers, and CLG has suggested that it will publish further guidance on this matter.

There is some concern that the guide is too strong in discouraging working on sites, on the grounds that they are essentially residential. There is a need to ensure that sites are safe and that any work does not have a negative impact on site residents, but TLRP is concerned that it may be a mistake to be too prescriptive.

Planning Update

South West England Regional Spatial Strategy Examination in Public: Panel Report

As reported in the last newsletter the Planning Officer with the help of Tony Thomson, FFT Trustee, attended the three day examination in public into the planned distribution of new pitches in the south west.

The Panel Report has now been published and makes interesting and encouraging reading (it can be found on the Government Office of the Southwest Website: www.GOSW.gov.uk).

FFT, with others, managed to present enough local evidence at the EiP to get some small changes to the numbers allocated to each district (overall an increase of about 100 residential pitches). Perhaps more importantly the evidence and concerns about the assessment process coming from the Gypsies and Travellers' side prompted the Planning Inspectors who carried out the examination to write an additional chapter to the report beyond their immediate brief of looking at the wording of the relevant policy and deciding on pitch numbers to be planned for in each district.

Their comments in the Further Thoughts Chapter will be useful for the next round of Assessments (due in 2011) and in helping to ensure that the process is better.

In particular they highlighted the following:

- The need for revised best practice guidance which should take into account the national experience of GTAAs to date.
- Their considerable concerns about the reliability of underlying data and the robustness of the final figures produced.
- The need for a greater degree of openness about the whole process. In their view this could be achieved by either GTAAs being carried out independently of local authorities or by a joint working party, which includes members of the Gypsy and Traveller and settled communities, or by having some method by which final figures are independently audited.
- Local authorities need to make greater efforts to engage the Gypsies and Traveller communities, a difficult but not impossible task.
- The need for further work on the numbers of Gypsies and Travellers who may wish to transfer

from housing.

More needs to be done to try and establish where those who have a need for accommodation would prefer to live. Such an approach may help achieve a better balance of pitches between districts.

It may be necessary to undertake much larger scale survey work across the whole community to establish a true picture of need.

They identified the need for the guidance to be amended or altered so that it adequately addresses the needs of new Travellers and Travelling Showpeople.

One of the successes at the EiP was the recognition by the Planning Inspectorate for the need for stopping places - specifically further consideration should be given to ensuring that a network of temporary stopping places are provided nationally, in addition to residential and transit pitches, so that wider needs can be met both now and in the future.

This does seem to be the first time that this issue has been officially recognised.

The Inspectors also endorsed our view that

in making provision for additional pitches, there is a need to ensure that the need to bring existing provision up to an acceptable standard is not overlooked and to ensure that if pitch numbers are reduced by refurbishment that provision for appropriate replacement pitches is made at the same time.

The issue of affordable pitches was recognised and local authorities will have to give particular consideration to providing an appropriate number of affordable pitches.

The Inspectors highlighted the slowness of delivery and identified measures to speed delivery.

Finally the panel report in one of its 17 recommendations indicated that Annual monitoring Reports should include details of the delivery of additional pitches and also the incidence of unauthorised sites for Gypsies and Travellers and Travelling Showpeople.

The Panel report must be regarded as a significant move forward though FFT still has misgivings about the level of identified need.

Planning Update cont.

In October a similar exercise will be gone through for the East Region with an Examination in Public at Letchworth whilst both the London and South East regions will undergo the same consultation and examination process in the autumn and spring.

The Midlands and Northern regions lag behind somewhat.

We would encourage anyone with evidence of need in London or the SE to contact the Planning Officer over the coming months so that we can continue to build up evidence to present at the EiP.
