# Government Launch new planning consultation



The deadline for responses is **23 November.**

We urge as many people as possible to respond.

**The government have launched a disastrous new planning consultation which proposes that the definition of Travellers be changed to only include those who travel.**

This ignores the fact that it is very difficult to travel these days as there are few transit sites and people are constantly evicted when stopping on the roadside, and that if you live on a council site your licence agreement doesn't allow you to travel for more than a set number of weeks a year, or you will lose your pitch. It also ignores the fact that lots of Gypsy and Traveller families are living in housing due to the huge shortage of pitches.

These proposed changes are a huge attack on Gypsy and Traveller culture and would result in even fewer sites than are currently provided being built and even more people ending up in housing.

**The GRTPA, launched officially in Westminster on July 17th, 2014, was founded in 2013 by Jim Davies, a Thames Valley Police officer who is an English Romany Gypsy, and Petr Torak, a Czech Roma police officer working in the UK.**

Racist discrimination is an ongoing serious problem both by the police against GRT people and within the police against colleagues with those backgrounds. The main aims of the Association are to support police officers from GRT backgrounds in their professional lives and to foster good relations between the police and GRT communities.

Membership is open to anyone who works in the police, regardless of ethnicity.

The South Downs National Park Authority has approved Brighton and Hove City Council's application to build a permanent Travellers' site next to the existing transit site at Horsdean.

The site will provide twelve permanent pitches in addition to the 21 transit pitches that are already there. Eileen Maughan and Margaret Murphy were present at the planning hearing meeting; Eileen Maughan spoke 'eloquently and from the heart in an intimidating environment', according to an FFT staff member who was there, and members were 'visibly moved'. ## 'Crystal's vardo' at Oakwood Men's Prison

In its third year 'Crystal's Vardo' took to the road in June to celebrate Gypsy Roma Traveller History Month. We visited Cardiff, Bristol, London, Kent, Surrey, Nottingham and Wolverhampton!



Each performance was a significant and moving experience but the one that the team and I were most apprehensive about was Oakwood Men's Prison in Wolverhampton. But the visit was one of the most uplifting and rewarding experiences I have had. The prison staff were extremely welcoming and the prisoners a fantastic audience, very responsive.

The audience was very culturally diverse, made up of Travellers from the Romany,

Irish Traveller and Roma communities together with other ethnicities and faiths. An amazing discussion opened up and different communities were able to see how much history and even culture they shared.

The Traveller prisoners were given a chance to be proud of their heritage and the non Travellers given an insight into the persecution Travellers have suffered through history.

The prisoners thanked us afterwards; they were very enthusiastic and said they had never had theatre at the prison before.

I hope the play and its message will have a more lasting impact on the prisoners and the staff at Oakwood. We would love to take 'Crystal's Vardo' to more prisons and youth offending units.
