Changes at FFT

As the newly appointed Director of Friends, Families and Travellers I am delighted to have the opportunity to tell you something about some of the exciting new initiatives that we are going to be starting this summer.

For many years FFT has provided an advice, information and casework service for Gypsies, Irish Travellers and other Travellers, and this will continue. However we have long been aware that the work we do is only the tip of the iceberg in meeting the needs of those who seek our help. For that reason we are refocusing the work of the unit to enable us to work with mainstream advice agencies such as Citizens Advice Bureaux to help them to improve the services that they provide to Gypsies and Travellers. We have been awarded three years of funding from the Big Lottery to undertake this work. It will be delivered by our Traveller Advice Project under the leadership of Emma Nuttall.

We are also going to build on the success of the Cyberpilots project managed by Tammy

The Sun's Stamp on the Camps campaign

Following the Crown **Prosecution Service's** decision not to prosecute The Sun newspaper under an Incitement to Racial Hatred Charge, the Press **Complaints Commission** (PCC) considered a complaint by Andrew Ryder of the Gypsy and Traveller Law Reform Coalition (G&TLRC) as to whether the Sun had breached the PCC's Code of Practice. The decision was that there was no breach of the code and the full reasons for the decision are as follows:

Commission's decision in the case of Ryder v The Sun.

The PCC noted that the complainant had raised concerns that the newspaper had breached Clause 1 (Accuracy) and Clause 12 (Discrimination) of the Code in its coverage of issues relating to Gypsies and Travellers. Ryder had also contented that the articles were offensive and designed to incite racial hatred.

Turning first to the complaint under Clause 1 (Accuracy), the PCC noted that the complainant had raised the following concerns: that the newspaper's coverage had been designed to mislead readers into believing that the government was allowing Gypsies and Travellers to set up camps wherever and that the third article headline "Sun campaign" had misrepresented government policy, which was in fact designed to reduce the number of unauthorised

.... Furey, to develop the web-site and work with Gypsy and Traveller young people to provide innovative educational materials that can be used by Traveller Education Services, voluntary organisations or by the young people themselves. We are grateful to the Commission for Racial Equality for giving us the funding to carry out this project.

This is a busy time in the planning profession with Councils up and down the country preparing their Statements of Community Involvement, Housing Needs Assessments and policies to respond to the new Planning Circular. To date, pressure of other work has made us unable to respond to the dozens of local authority consultations that arrive in our office but, thanks to the generous support of the Allen Lane Foundation and Garden Court

Chambers, we will shortly be recruiting a part-time Planning Officer. This will enable us to engage in this work and, hopefully, develop some good practice models for local authorities to follow in their planning processes.

The successful Sussex Traveller Women's Health Project, managed by Zoe Matthews, has now come to an end but the much needed work of helping Gypsies and Travellers in East Sussex to access health and social care services will continue, thanks to funding that we have received from the Home Office under Invest to Save Round 8. Zoe and her team - Avril Fuller and Sally Burnett - will be working in partnership with Sompriti, an organisation that helps Black and minority ethnic people in East Sussex, and the Adult Social Care service of the County Council, over the next

three years to deliver improved services to Gypsies and Travellers in East Sussex and, hopefully, develop models of good practice that will be adopted elsewhere.

Our staff complement has been augmented by the arrival of Clare Bingham, who will be taking over most of the day-to-day casework from Emma, and Suzanna King our new administrator/bookkeeper. We are delighted to have them with us.

So, after years of struggling to survive, we now have some security of income to enable us to continue and expand our work. As always we are very grateful for the support and help given to us by the Traveller Aid Trust without which Friends, Families and Travellers would have ceased to exist.

Westminster Briefing entitled "Planning and Enforcement of Gypsy and Traveller Sites: Meeting the Challenge" will be hosted by The House Magazine on Thursday 18th May 2006 in Westminster.

The Government has recently published new guidance on planning and

enforcement in an effort to address the shortage of authorised Gypsy and Traveller sites and to strengthen enforcement against the problem sites. Delegates at this Briefing will have the opportunity to consider the new guidance and also assess the likely impact recent legislation such as the Clean Neighbourhoods

and Environment Act 2005, the Anti-Social Behaviour Act 2003 and the Housing Act 2004 will have for local authorities.

Clause 1 (Accuracy) states that the press must take care not to publish inaccurate, misleading or distorted information, including pictures. It also entitles newspapers to be partisan, provided they distinguish between comment, conjecture and fact.

The PCC noted that the 3rd article stated that John Prescott had ordered local councils to "go soft" on Travellers' camps, and "turn a blind eye" to problems created. The article had also indicated that John Prescott had warned local authorities that Travellers suffered racial discrimination in planning applications, and suggested that his orders could create more than 300 new camps. However, the article had not detailed the measures that were being implemented by the government.

Taking this into account, the PCC considered that it would be clear to readers that the articles represented the newspaper's own interpretation of John Prescott's actions, and government policy. No breach of Clause 1 (Accuracy) has therefore been determined. The PCC noted that the complainant had also raised concerns over the use of a photograph on the front cover of the newspaper, which he believed to have been taken in the 1980s. However - in the Commission's view - the photo had been illustrative of the subject of the articles.

The Sun had not claimed that it was contemporary. The PCC was satisfied that the use of this picture did not raise any issues under the terms of Clause 1 (Accuracy).

The next task for the PCC was to consider the complaint under Clause 12 (Discrimination) of the Code. The complainant had explained that the G&TLRC had been contacted by a number of Gypsies and Travellers who had felt threatened by the articles, and in particular the headline "Stamp on the camps". Moreover, the Commission for Racial Equality had recorded an increase in incidents of discrimination against Gypsies and Travellers after publication of the articles. The complainant also outline that Travellers at sites that had been depicted in the newspaper - for example those at Dale Farm - had informed him that they found the article to be

particularly offensive.

Clause 12 (Discrimination) of the Code states the press must avoid prejudicial or pejorative reference to - amongst other things - an individual's race.

However, the PCC emphasised that this clause was designed to protect the rights of the individual and is not applicable to groups of people. Given that no individual has been referred to in the article in a prejudicial or pejorative manner, the PCC made clear that no breach of Clause 12 could be determined.

The PCC finally emphasised that it could only come to a view under the terms of the Code. It could not therefore comment on the complainant's concern that the newspaper had attempted to incite racial hatred. Moreover. it made clear that taste and offensiveness were matters for editorial discretion and were not ones on which it could comment.

Reports

May and June this year will see the publication of three important reports.

The Commission for Racial Equality will publish the results of their scrutiny into Local Authorities' race equality duty towards Gypsies and Travellers.

The Social Exclusion Unit will publish their 'Frequent Movers' report, which includes Gypsies and Travellers

The Local Government

Association will publish the report of their Gypsy and Traveller Task Group, as chaired by Councillor Richard Bennett, which has been looking at provision and enforcement.

Royal Welsh Show

FFT has been informed by Cyngor Sir Powys County Council, that a temporary caravan site is not available this year. "Since last year's Royal Welsh Show Powys County Council has again tried to find a suitable site for use by Gypsy and Traveller families attending the show. Advertisements have been placed in local newspapers inviting farmers and other landowners to contact the Council if they had suitable land available. Unfortunately, no suitable offers of land have been forthcoming and no other land is available in the Builth Wells area to accommodate a temporary site. In the circumstances, I would advise all Gypsies and Travellers intending this year's show to make a reservation as soon as possible for a caravan pitch on one of the licensed caravan sites (FFT has a list of these four sites – please contact the office)".

We were also informed that the Ysciog Farm next to the A470, near Builth Wells is not available.

In 1999, FFT was one of five organisations short listed for the Human Rights Award, part of the UN International Day of Human Rights.

FFT is run by a management committee made up of directors elected by the membership.
