UK Government found in breach of Article 8 of the European Convention on Human Rights.

Congratulations to Keith Lomax, the Leeds solicitor who took the successful Connors v - UK case to the European Court of Human Rights. The UK Government was found in breach of Article 8 of the European Convention on Human Rights. Mr. Connors wasawarded 14000 Euro damages.

There is currently no proper security tenure for Gypsies and Travellers on Local Authority sites. Only four weeks notice and a court order is required to evict a Gypsy and Traveller from a local authority site. The case will impact on the security of tenure on official sites and it is now for the Government to act accordingly. The court ruled that:

• There was no evidence that eviction by summary procedure was used as a means of maintaining a turnover of vacant pitches or of preventing families from becoming long-term occupants. Anti-social behaviour, on local authority Gypsy sites could not, in itself, justify a summary power of eviction, since such problems also occurred on local authority housing estates and private mobile home sites. In such cases, authorities made use of a different eviction powers and might only proceed with eviction after an independent court review of the justification for the measure.

• The Court noted that security of tenure protection covered privately run Gypsy sites, therefore the Court was not persuaded that there was any particular feature about local authority Gypsy sites which make their management unworkable if they were required to establish reasons for evicting long-standing occupants.

• The Court did not find any indication that Gypsies would lose the advantage of low financial costs attaching to local authority sites. According to the submissions by the local authority, Gypsy sites did not benefit from particularly low licence fees.

• The Court was not persuaded that <u>the necessity</u> for summary eviction of the applicant and his family had been sufficiently demonstrated by the United Kingdom Government. The power to evict, without the burden of giving reasons justifiable to an independent tribunal, had not been convincingly shown to respond to any specific goal or to provide any specific benefit to members of the Gypsy community. It would rather appear that the situation in England as it had developed, for which the authorities had to take some responsibility, placed considerable obstacles in the way of Gypsies pursuing an

I am writing this paper following recent high profile and very traumatic evictions that have taken place around the Country. For the purposes of this paper, I will divide planning sites into: a) those where it is clear that (at least at this stage in time) attempts at gaining planning permission have completely failed; b) those sites where there is still a chance or hope of obtaining planning permission.

A) Planning sites where the planning permission route has failed (usually after many attempts).

The approach of the Travellers Advice Team in such cases is to assist the clients in question to make homeless applications relying on the case of R (Margaret Price) v - Carmarthenshire County Council. Obviously, in order to hope to succeed in such applications the client or clients in question would have to be homeless (which they will be at that stage), in priority need (e.g. with dependant children), and not intentionally homeless (can sometimes be a problem if they have previously left official sites or left housing).

Such an application will immediately trigger the duty to provide interim accommodation under Section 188 of the Housing Act 1996. Following the Margaret Price arguments on cultural aversion to conventional housing, we would then argue that suitable interim accommodation is a piece of land, site or pitch where they would at least temporarily be authorised to stay and, failing that, that they should be allowed to remain where they are on the planning site until the homelessness application has been properly dealt with. At that stage, and until suitable other interim accommodation is provided, we will seek an assurance from the Local Authority concerned that no enforcement action of any sort will be progressed. Failing such an assurance, it is very likely that an application for Judicial Review would be immediately lodged including within it an application for an injunction or stay on any enforcement action. If an injunction or stay is obtained or if a suitable assurance is obtained from the Local authority, then the client or clients will be safe for the time being from the kind of events we have seen recently.

If the clients do not qualify for the duty to accommodate under the Homelessness Legislation or if no assurance is received from the Local Authority and the Judicial Review route fails for some reason, then, as responsible legal advisers, we will at that stage advice the clients that they should vacate the land and, if they agree to vacate the land, we will negotiate with the Local Authority a vacation date. In these circumstances, if the clients state that they will not vacate the land, we would consider ourselves dis-instructed and inform all relevant parties accordingly. Once they have vacated the land, if they do, we would continue to actively assist them and seek to avoid a scenario of frequent evictions from roadside encampments as best we can .

The purpose of this "method" is to avoid arriving at blazing barricades. With certain clients we have picked up after some of the traumatic evictions that have taken place, we have seen the terrible affects this has had on Gypsy and Traveller families. It is all very well considering taking an action against the Police and/or the Bailiffs, but the responsible position from our point of view is to take all steps to avoid it reaching such a crisis. In this context it has to also be accepted that there are some sites where the planning route simply will not succeed or where the location is simply too inappropriate and, once again, the obvious responsible legal advice is to make that clear to the clients.

B) Planning Sites where there remains a chance or hope (sometimes a very good chance or hope) of obtaining planning permission.

Obviously in such cases, the clients are keen to put all their emphasis into the at-

tempt to gain planning permission and are therefore not normally interested in the possibility of making Margaret Price style homeless applications (though it is probably the case that they are homeless since they have no authorised place to stop at that stage). I would add that the latter point is not completely clear and there is a conflict in the cases which no doubt needs to be resolved at some stage. However, the Travellers Advice Team are concerned that certain Local Authorities will have had ideas put in their head by Bulkington and Meadowland. The direct action powers used in Bulkington and Meadowlands (which require no Court action by the Local Authority) were under Section 178 of the Town and Country Planning Act 1990. We are especially concerned since in one of our cases involving Chelmsford Borough Council (not the Meadowlands site), direct action was taken under Section 178 without any warning despite the fact that there was an ongoing (and perfectly possible) planning case. This obviously flies in the face of the House of Lords Judgment in South Bucks District Council - v - Porter (the first Porter case) but nevertheless it is perfectly possible for certain belligerent Local Authorities to seek to use Section 178 and/or Stop Notices (current Judicial Review challenge on compatibility on going in one of our cases) and/or injunction/ committal proceedings. The most worrying of all these possibilities is the use of Section 178. Therefore my proposal in this discussion paper is that in virtually all planning cases, assurance should be sought urgently from the Local Authority concerned that Section 178 powers will not be used. If that assurance is not forthcoming, the clients should be advised of the possibility of a Margaret Price Style application. Obviously the clients should be warned that if a suitable offer of a pitch, site or piece of land is made as a result of such an application, then that might in itself collapse their planning case. Nevertheless, even without a Margaret Price style application, it is always possible, of course, for a Local Authority in response

to a planning case to respond by suggesting suitable alternative accommodation. I am not, of course, talking about bricks and mortar accommodation in this respect (the Clarke case refers). If the clients then agree to a Margaret Price style application, then all I have explained under a) about the use of such applications and the possibility of a Judicial Review application if sufficient assurances are not received, applies again. Once again the purpose is to avoid precipitate eviction action. If the Local Authority do not give an assurance and the clients decline to make a Margaret Price style application, while we will be happy to pursue the planning case, they should be clearly warned about the possibility of direct action. Obviously if we get sufficient notice of direction action, we can attempt to forestall it but, as has been seen in recent cases, sometimes these situations come out of the sun at the Gypsies and Travellers concerned.

If the Travellers Advice Team do decide to adopt this approach (and I would stress again that this has not yet been decided) there are two major problems with it:-

1. The possibility of eventually having to lodge a separate Judicial Review application, aside from the planning case, will greatly increase the cost for private paying clients.

2. At present the Travellers Advice Team has a relatively small number of cases involving type A planning sites and in those circumstances we can cope with potential Judicial Review applications if it comes to it for those clients. However, we run hundreds of planning cases for Gypsies and Travellers. As a complete guestimate I would say that we must have at least 150 on the go at present. Logistically, it might prove very difficult for us if we were having to set up a large number of concurrent potential Judicial Review files. However there remains the hope that in many cases the Local Authority concerned would be happy to give an assurance about the use

of Section 178 powers. This might cut down the number of cases to just those Local Authorities that are keen on belligerent, direct action.

I will take this opportunity as well of mentioning our clients on roadside encampments, many of whom have no real possibility of pursuing the planning permission route. Once again a guestimate of our caseload as of today of roadside cases would be at least 200. For those clients, swift and direct action is a daily fact of life. Once again, for those clients, and for the general information of the GTLRC, Margaret Price applications are proving to be of great assistance and in many of my cases I have roadside encampments on locations that are not inappropriate which have been kept in place for very long periods of time and which remain in place. I would single out one group who face particular problems from the people on roadside encampments and that group is single, healthy, childless Gypsies and Travellers. These clients (following our brave attempt in the Court of Appeal in Myhill and Faith - v - Wealden District Council) will not be found to be in priority need and thus no full duty to accommodate will be owed to them. It is especially these clients who face the bleakest position at present.

The obvious answer to this dilemma is the re-introduction of the duty to provide or facilitate the provision of sites. I will not list the numerous powerful and influential reports that have suggested this is the solution. Obviously, for those Travellers who remain for most or all of the year nomadic, this must include not only permanent sites but also transit sites and emergency stopping places. When we were all staffing the FFT/TAT stall at the Glastonbury Festival, at least one Traveller expressed the view that the provision of sites would be used as an excuse for swift and constant eviction action. I would say in response to that, and as I have already said above, that, firstly, swift and constant eviction action is

a daily fact of life for Gypsies and Travellers on roadside encampments. The Margaret Price route can go some way to try and bring a halt to that ongoing eviction situation. However it also has to be recognised that the Margaret Price route will not work in terms of roadside encampments that are not on suitable locations and that, in some areas, there is immense defense of locations that might otherwise be appropriate. If there really was adequate provision of permanent sites, transit sites and emergency stopping places and provided they were suitable sites and that proper provision was made for all relevant groups i.e. Romani Gypsies, Irish Travellers, Scottish Travellers, Welsh Travellers and New Travellers, then surely we would all have arrived at the sublime position that we want to get to. Thirdly, I appreciate that some people understandably hark back to the days (long gone I am afraid) when Gypsies and Travellers stopped on common land and other traditional stopping places and were "tolerated" in those locations for reasonable periods of time. However I would point out that the history of Gypsies in Britain since 1500 has indicated a perpetual story of prejudice, discrimination and harassment even during times when it was easier to find stopping places. Eventually even the Native Americans and the Aborigines in America and Australia had to move to what was effectively a compromised position (and I am not suggesting that the ultimate successful compromise for those two peoples has yet been reached). Realistically, even for the "perpetual nomad", avoidance of swift and constant evictions will not be achieved without arriving at our realistic goal - adequate site provision of all sorts. For those who can take the planning route, we hope that the Planning and Compulsory Purchase Act 2004 and the amendment to DOE Circular 1/94 (awaited) might finally create a situation where there was a realistic possibility of setting up authorised sites. On the other side of things, it is clear that public site provision must be the other side

of the equation. I am interested to note that, as yet, we have only had one incident of the attempted use of the new Police powers of eviction under Section 62A of the Criminal Justice and Public Order Act 1994 which section is linked in to a direction to a suitable site. In that case we successfully backed off the Police on the basis that the location identified was not suitable. I trust that the Police will continue to hold off from using these powers, and I believe that the GTLRC should press them for an assurance to that end, until such time as adequate site provision in each relevant Local Authority area is achieved. Central Government really do need to come down hard on those Local Authorities that are not moving towards this goal

within their homelessness strategies, their local development documents and their approach to unauthorised camping.

As I have said at the beginning, I hope this discussion document will do just that start a big discussion about the issues, especially the issues arising from cases like Bulkington and Meadowlands and Kushti Bok to all of you!

Horsmonden - Back to the Green

"For the fourth year running, Gypsy people have defied the Horsmonden Parish Council who without proper consultation banned the traditional Gypsy gathering on the 2nd Sunday of September. Each year the Gypsy Council and the Romani Rights Association, their members and supporters, have been sure to attend the annual event.

September 2003 saw what was one of the best turnouts since the cancellation, a good two hundred plus people were on the green with horses for sale, various horse drawn vehicles and harness, Thomas Acton had his book stall and the Gypsy Council had an information stall with videos and tapes for sale. The police presence was low key and friendly, a marked contrast to the past three years. The Parish councillors were again once again noticeable by their absence. The whole event passed off peacefully with all those attending having a very pleasant day. See you all there this September, Sunday 12th."

A Threatened Culture

In February 2003 I read an article, regarding Gypsies & Travellers, on pages 23-25 of a magazine called "Hull in Print", which is published by the Kingston upon Hull City Council. The articles heading reads "End of the Road". A large part of my family are Gypsies & Travellers, my Father, Peter (Peter Mercer MBE) is a Romany Gypsy.

Knowing the passion that my Father has for the Gypsy & Traveller culture and how he has worked for many years promoting education, welfare and civil rights, for Gypsies & Travellers in Britain, and abroad, I found this statement very serious and extremely disheartening. It is stating the end of a culture, a culture that has existed in Britain since Romany Gypsies first came from Europe in the 16th century.

I immediately got my trailer (caravan) ready for the road. I wanted to see for myself, if the statement "End of the Road", was a forecast of what is in store for the Gypsy & Traveller Culture. So myself and my 9 year old son, Aidan, took to the road, making contact with several transient Gypsy & Traveller families. Highly mobile Gypsies, Travellers and Irish Travellers, living on the borders of urban society.

Staying with one mobile group I witnessed the deliberate hardships put upon these people, by a society that publicly prides itself on tolerance and cultural preservation. Moving from place to place, setting up camp after camp, it was obvious that many members of the public did not welcome this culture. We were faced with racial abuse, violence and wilful vandalism of our trailers.

Neither the Law nor the councils have shown much sympathy towards the needs of this nomadic culture. Faced with the constant threat of evictions, County council warrants and Section 61 of the 1994 Public Order Act, transient Gypsies and Travellers can find accessing welfare and education almost impossible.

On attending County Court hearings, as an advocate for transient Gypsies & Travellers, education and welfare assessments are not given greatest consideration in these eviction cases. Even though there are charters in place, such as the "Hull City Council Tolerance Charter" not much evidence of tolerance has been shown to transient Gypsies and Travellers by the council. If it wasn't for the 1998 Human Rights Act, I would not have been allowed to speak on behalf of Gypsies and Travellers facing eviction at the County Courts.

On occasions friends and myself have telephoned the Hull City Council, enquiry line, as members of the general public, enquiring on Gypsies and Travellers in the town, using the phrase, "who do I talk to about Gypsies & Travellers?", we were immediately put through to the "Anti-Social Behaviour Team". The enquires could have been about any number of issues, relating to Gypsies & Travellers. Being put through to this department gives the caller an immediate opinion on Gypsies & Travellers, as the "Anti-Social Behaviour Team", usually deal with issues relating to crime, violence and drug misuse.

The councils could help transient Gypsies & Travellers with facilities, such as waste skips etc, enabling Gypsies and Travellers to help keep camps clean. Empty land and grounds could be designated each year by the councils and sponsored landlords, giving appropriate agencies, such as the Travellers Education Services etc, better access to travelling families. However, even after requesting such facilities, they never arrive. Not allowing Gypsies & Travellers to prove that they can keep camps clean and organised, causes public unrest and adds to the breakdown in public relations.

Every day the media tells us how Britain welcomes international cultures, however, a culture that has been part of British history, for centuries, faces ethnic cleansing, through prejudice and forced social assimilation. Steps must be taken to help preserve this misunderstood an threatened culture. Prejudice against Gypsies and Travellers needs to be addressed, or the race and culture, which is centuries old, could be lost forever, and will become another extinct flower in Britain's own cultural garden.

Firle Bonfire Society not prosecuted

The Attorney General has decided that the twelve villagers in Firle, Sussex who were involved in the burning of a caravan and effigies of Gypsies in October 2003, in the wake of an unauthorised Gypsy and Traveller encampment, will not be prosecuted. Describing it as a "complex and challenging" case, the CPS said there was insufficient evidence to go ahead. The society denies claims there was any racist intent behind its actions.

Reviewing lawyer Patrick Stevens said that for anyone to be prosecuted, it could only be on the basis of their own words or acts. He said the general picture, which emerged from the evidence, was of a "fairly disorganised group of individuals playing different parts in the event".

Noelette Keane, Director of Irish Traveller Movement in Britain says: "The Gypsy and Traveller community will be appalled at this decision. The caravan burning is the cause of grave concern. The incident is a reflection of the tensions created between the Gypsy and Traveller and settled communities as a result of the lack of stopping places for Gypsies and Travellers in the UK. Those tensions still exist and this Government needs to take decisive action in creating a national network of residential and transit (temporary stopping places) sites for Gypsies and Travellers. "

Len Smith of the Gypsy & Traveller Law Reform Coalition says: "The Gypsy and Traveller community havebeen subjected, as the Firle incident showed, to an increasing wave of intolerance and what I would suggest is incitement to racial hatred. This Government needs to introduce a duty to provide and facilitate sites. This will reduce the level of intolerance and tensions and improve Gypsies and Travellers access to services. It is a win win situation".

Housing Corporation money to be used for site construction

An article entitled "Corporation will pay RSLs to build and manage Gypsy site" appeared in Housing Today. It states that the Government is to allow Housing Corporation money to be used for site construction. This was the aim of clause 14 in the Traveller Law Reform Bill.

I think there is still a need for a statutory duty to provide/facilitate. It is very clear to me that support is growing for the clauses for the Housing Bill drafted by the CRE and tabled by Lord Avebury and Baroness Whittacker. One of these clauses calls for a statutory duty.

The article refers to an accommodation needs assessment for Gypsies and Travellers, which will be in place in 2005. Local authorities will have to produce their housing needs assessment (including Traveller sites assessment) which will then be quality assured by the regional housing boards. It will become part of the regional spatial strategies and the regional spatial strategies will allocate provision - the need to make provision - either on a sub-regional basis or on an individual local authority basis and then the local development documents which are produced locally will have to be in compliance with the regional spatial strategies. I gather that if the local development document does not contain provision for Traveller accommodation which is compatible with the assessed need then the Secretary of State can direct the local authority to modify the document and undertake a revision. Much would depend on the willingness of a Secretary of State to use their powers and the fairness and accuracy of the accommodation needs assessment.

At the ODPM Select Committee in July an official named Mr Stambollouin stated "We are hoping to publish the new needs assessment methodology before the end of this year and we would expect local authorities and regions to begin coverage by the middle of next year and there to be reasonable coverage by the end of next year. Once those assessments are in place they will become a material consideration on appeal so if there are sites being made and Gypsies come forward with proposals for Gypsy site development then one of the material considerations will be the assessment of need".

I believe the material consideration factor is a turn on clause 6 in the Traveller Law Reform Bill, which wanted the extent to which a council had complied with its duty to provide/facilitate and developed an accommodation programme for Travellers including an assessment of need to be material considerations in the planning process.

Extracts from Housing Today, 06.08.04 Corporation will pay RSLs to build and manage Gypsy sites By Joey Gardiner

"The Housing Corporation will pay registered social landlords to build and manage Gypsy and Traveller sites as part of a cross-party deal, Housing Today has learned. The measure will be added to the Housing Bill, which is now in committee stage at the House of Lords. It will form part of a shake-up of provision for Gypsy and Traveller sites, to be unveiled by the ODPM in autumn. The ODPM will not, however, insist that councils provide sites for Gypsies. Labour peer Lord Eric Avebury has tabled an amendment to the Housing Bill calling on the government to reinstate the obligation on local authorities. But a source said the ODPM would instead launch a consultation calling for the provision of Gypsy and Traveller sites to be treated as a housing issue rather than a planning problem. This means councils would be forced to take account of Gypsies and Travellers in their housing needs assessments.

The ODPM is also considering whether to set criteria for sites, including distance from schools."

Hello Folks! And welcome to the summer, here's wishing you all a good travelling season. One seasoned Traveller I met a while back said to me, "you haven't got a clue what being a proper Traveller is like!". He proudly talked of his work and the money he made, his

family, sons and their families, his vehicles and caravans and the thousands of miles he covered all over Europe every year. Well, what I say is, if its in your blood, or your inclination, and you get the itch, then there's no stopping you, and a Traveller you are! I am adopted, and almost certainly from the travelling community in origin, although I haven't yet traced my parentage. I spent the first part of my life living in a house which was dusty, dark and gloomy. I didn't fit in and didn't understand why. I was always late home from school because I wanted to play outdoors, so I was sometimes punished and sent to bed without my supper! In later years, after a dismy fifth move since 2000, never mind the countless ones beforehand – to honour my chosen lifestyle. I managed to hang on in there for six months, but now, I have to dismantle the bender after sleeping in it twice and put the caravan back into storage where it has spent most of its time since I swapped it for my old



astrous teenage marriage, I lived in sub-standard housing on rough council estates in poverty and isolation. I dreamed of the day when I could freely visit hills and woodland and beaches. I became very ill and it is only since I took up the nomadic and outdoor lifestyle that my health improved. I haven't lived in a house for nearly fifteen years and would prefer not to, unless it was a nice log cabin on my own patch of land. However, for most of us, the way we would like to live is denied to us due to ridiculously rigid (planning) control which is totally unrealistic for most people's needs. Agenda 21 needs to be honoured to meet the challenging climate - both weather patterns and human attitudes - so that those of us who need a base from which to live our travelling lifestyles can have one. And a base is crucial in a bureaucratic society, or else life is a stressed-out miserable existence. For more and more of us, who want to honour our spirits by living more naturally, this does not mean bricks and mortar and microwave ovens. We do want low impact. Self-built dwellings, or a caravan or static on a patch of grass.

This caravan and bender was my own latest attempt -

Bedford J-Type four years ago. In the meantime I am still looking for my own little plot which I can put this caravan and bender. I am being ambitious, as usual. I hope it will be in South Wales, where, currently quite a few hopefuls are testing the waters and trying to set a precedent with low impact dwellings. Just a small plot for me, please, to love and cherish and help blossom, a place from which to write my music and books, grow a few veg and honour my Travelling lifestyle as well – and I am proud to say that the Spares File, now in its tenth year, has been written mainly on the road! Is this too much to ask in Britain in the 21st century? Or are we on the verge of a big shift, of which we can truly say: "It took a long time coming, but it was well worth waiting for".

The seasoned Travelling man I met those years ago who was so critical of my patched up little old Bedford, and me, told me all about his rich and varied life, but, sadly, didn't wait to hear my story. I hope my coming future success will be an inspiration to all of us 'little folk' out there who keep trying to honour our travelling spirit and nomadic lifestyle because whether or not we begun it out of necessity, we love it and we hold our vision because this is the way we want to live our lives – naturally, and by treading lightly on our mother planet.

It has since grown into a nationally recognised voluntary organisation which serves the whole spectrum of the Traveller community, both traditional and new, settled or on the road.

The majority of work promoted by FFT is carried out by an Advice and Information Unit based in Brighton and covers evictions, harassment, planning, employment, benefits, education, health, civil rights, discrimination and legal representation. The Unit is also active in research, monitoring, mediation and policy development at local and national levels.

In 1999, FFT was one of five organisations short listed for the Human Rights Award, part of the United Nations International Day of Human Rights.

FFT became a company (non-profit voluntary organisation) limited by guarantee on the 14th of July 1998, no. 3597515. The company is run by a management committee made up of directors elected by the membership. Management committee meetings are held every six weeks and are open to all members.
